CAMP INFORMATION/RULES

1. All payments are to be made in full no later than June 1st. Campers will not be permitted to stay at the camp if there is a balance due.
2. Campers are to arrive between **8:50** and **9:00** am each morning- ***NO EARLIER!*** They are to be picked up no later than **3:00** pm each evening. Any campers arriving before 8:50 am or leaving after 3:15 pm may be left unsupervised. Please be sure you do not leave your campers there alone. There will be a \$1.00 per minute charge for all children not picked up by 3:15 pm. (In case of an emergency, please call Outlaw Stables as soon as possible to make arrangements. 582-8221).
3. Campers should eat a healthy balanced breakfast before arriving at camp. Remember they have a long and active day ahead of them, so be sure they eat a complete meal.
4. Campers are to pack a lunch for each day. Please be sure to include a drink or change so they can purchase a drink. The lunch needs to be a substantial and healthy meal. **THEY WILL BE HUNGRY BY LUNCH TIME.** Morning and afternoon snacks are provided by Outlaw Stable.
5. Be sure to notify a camp employee if your child's lunch or other items need to be refrigerated.
6. Campers need to wear proper riding attire while at the camp.
 - Wear boots with at least a 1/4 inch heel. (Dress boots are not acceptable.)
 - Wear a comfortable shirt that has short sleeves. Baggy clothes, tank tops, or spaghetti strap shirts are not acceptable. They can pack lighter clothes for the afternoon, but cannot ride if they do not have the proper attire.
 - All jewelry (necklaces, earrings, bracelets, anklets, rings, etc.) should be left at home. These items can be dangerous to wear while working with horses.
 - Wear or pack long pants, preferably jeans, for riding. **Students without long pants or jeans will not be permitted to ride.**
7. Campers should pack....
 - *Sunscreen with the SPF appropriate for their needs.
 - *Insect repellent.
 - *Change for drinks or a thermos with a drink in it. Outlaw Stable will provide drinks at snack time, and water throughout the day.
 - *A swimming suit
 - *A towel
 - *Any medications and instructions.
 - *Proper riding attire (as listed above.)
 - *A change of clothes
 - *Shorts for after they have ridden.
 - *Money for swimming at the public pool (\$5.00 should be plenty.) We try to go to the pool on Friday after the lessons – weather permitting.

STABLE AND INSTRUCTORS

This RELEASE OF LIABILITY is made and entered into this _____ day of _____ 20 ____, by and between OUTLAWSTABLE/TARA DAWN HAZEN/LINDSAY VULICH, its agents and employees, hereinafter designated as OUTLAWSTABLE/TARA DAWN HAZEN/LINDSAY VULICH and _____, hereinafter designated as RIDER; and if RIDER is a minor, RIDER's parents or guardian, _____.

In return for the use today and on all future dates of this property, its horses and equipment, and any other location or property in which riding lessons, horse shows or events are conducted, all facilities and services of OUTLAWSTABLE/TARA DAWN HAZEN/LINDSAY VULICH, the RIDER, his/her heirs, assignees and legal representatives, hereby expressly agree to the following:

1. RIDER/Guardian acknowledges that there are risks in horseback riding and the activities in and around stables and the horses, including the risk of injury or death and damage to personal property. RIDER voluntarily assumes all such risks for themselves while around the horses, instructor or properties, and any other time using skills learned while working with OUTLAWSTABLE/TARA DAWN HAZEN/LINDSAY VULICH. RIDER does for himself/herself and his/her heirs, executors and assigns forever release OUTLAWSTABLE/TARA DAWN HAZEN/LINDSAY VULICH for any claim, cause of action or demand for personal injury or death or property damage arising from or relating to his/her activities with or at or from OUTLAWSTABLE/TARA DAWN HAZEN/LINDSAY VULICH.
2. It is the responsibility of the RIDER to carry complete insurance coverage on his/her horse, personal property and him/her self.
3. RIDER/Guardian agrees to indemnify and defend OUTLAWSTABLE/TARA DAWN HAZEN/LINDSAY VULICH against and hold it harmless from, any and all claims, causes action, damages, judgements, costs or expenses, including attorney's fees, which in any way arise from RIDER's use of or presence upon OUTLAWSTABLE/TARA DAWN HAZEN/LINDSAY VULICH properties or facilities.
4. RIDER/Guardian agrees to abide by all of OUTLAWSTABLE/TARA DAWN HAZEN/LINDSAY VULICH rules and regulations.
5. RIDER/Guardian understand the campers will be going to a public pool for swimming activities. The public pool provides life guards and carries their own insurance should any injury/accident happen. By signing below Rider/Guardian agree to hold Tara Dawn Hazen/Outlaw Stable and Lindsay Vulich harmless should any injury, accident or death occur while on the grounds, during transportation, and at the public swimming facility.
5. This agreement represents the entire agreement between the parties. No other agreement or promise, verbal or implied, are included unless stated in this written agreement.
